#### THINGS TO KNOW FROM YOUR TRUST DEPARTMENT

#### **Year-End Tax Planning**

Wow, time flies when you're having fun! The end of the year will be here before you know it, so it's time to start thinking about taxes. (Yes, I did just say taxes and fun in the same sentence.) Here are some ideas to think about before December 31 to hopefully save you a little money come April 15.

- **Retirement Accounts** Have you made your pre-tax or tax-deductible contributions yet this year? Don't forget, people over the age of 50 can make extra "catch-up" contributions as well.
- **Qualified Charitable Distributions** If you're taking required minimum distributions from your retirement account and you don't need the cash yourself, you can make a qualified charitable distribution (QCD) directly from your retirement account to a qualified charity.
- **Annual Gifting** For the 2021 tax year the annual gift exclusion remains \$15,000. Each taxpayer can gift up to \$15,000 to any individual(s) with no gift tax consequences. That means Grandma and Grandpa together could give each grandchild up to \$30,000 for Christmas (perhaps as a contribution to their 529 college savings plan).
- **Health Savings Accounts** If you have a high deductible health plan, you can contribute \$3600 to your individual HSA or \$7200 for families. While HSA contributions may be subject to payroll taxes, they are not subject to income tax. If you are age 55 or older, you can make an additional \$1000 "catch-up" contribution for the year as well.
- Medical Expenses Out-of-pocket medical expenses in excess of 7.5% of your adjusted gross income can be deducted if you itemize on Schedule A, so start gathering those receipts and insurance statements now.
- **Moving Expenses** Did you move more than 50 miles for a new job this year? Ok, maybe that was just me, but don't forget to remind the recent college graduates in your life of this deduction for storage, moving, and personal travel to their new home.
- **Section 179** If you have Schedule C, Schedule E, or Schedule F income from the operation of a trade or business, you can expense certain purchases of tangible property rather than depreciating them again this year. Maybe your rental duplex needs that new refrigerator before December 31st after all.

Some of these deductions are phased out for higher income filers, so be sure to ask your tax preparer which you qualify for. And have fun sorting through that file you've been accumulating but haven't really looked at since last February.

### Money Mules Fuel Fraud

#### What are money mules?

Money mules are people who receive and move money obtained from victims of fraud. Some money mules know they've been recruited to assist criminal activity, but others become money mules without realizing their activity is benefiting fraudsters.

#### How do people become money mules?

- Responding to a job advertisement or social media post that promises easy money for little effort.
- Helping someone they've met online (possibly on a dating website) or over the phone by agreeing to receive and transfer money.

Whether it is cash, packages, gift cards, or virtual currency, assisting money movement puts money in the pockets of criminals and could lead to serious consequences for you.

By knowing the signs of money mule activity, you can protect yourself and your community, and avoid assisting fraudsters.

#### Think twice about agreeing to help people move money!

- Don't open a bank account or move money at someone else's direction.
- Don't give someone access to your bank account or debit card.
- Don't allow money from people you don't know to be deposited into your account.
- Don't take a job that promises easy money and involves sending or receiving money or packages.
- Don't agree to receive or forward packages.
- Don't agree to purchase gift cards or virtual currency at someone's direction.

#### If you've acted as a money mule, it is never too late to stop!

- Stop communicating with the person giving you direction.
- Tell your financial institution and consider changing accounts.
- Report suspicious communications or activity to law enforcement.
- Protect yourself by learning about scams and money mule activity.

Money mules help international criminal networks steal money from senior citizens, businesses, and people just like you.



#### **LIVE BETTER WITH HOUSEPLANTS**

There are many scientifically proven benefits to having plants in your home. Indoor plants can remove toxins from the air in your home and actually help you concentrate better!

**Reduce Stress** – Stay calm, carry on and buy a plant. People who keep flowering houseplants in their home feel happier, less stressed and more relaxed, says an article in the Journal of Environmental Psychology about the super effects that our flowering friends bring to our homes. As it turns out, flowering plants add positive energy, which reduces stress-related depression.

**Improve Indoor Air** – The Environmental Protection Agency (EPA) found the air in your home may be more polluted than the air outdoors. Scrub clean your air with houseplants! Strategic plant placement in your home improves air quality—the air that you breathe every day.

**Concentrate Better** – Adding indoor plants to your home or workplace can increase your memory retention and concentration, according to a university of Michigan study. The placement of plants in work areas creates a positive environment and increases your ability to concentrate (up to 20 percent!) on your project or task.

#### Other Health Benefits

**Allergy Relief** – Researchers found that rooms with plants have less dust and mold than rooms without any foliage. Leaves and other parts of the plants act as natural filters to catch allergens and other airborne particles. Common low-light houseplants like the peace lily can do the job. Avoid plants with pollen or spores.

**Spider Plants for Moisture** – Furnaces and air conditioners can sap humidity indoors, especially in the winter. That raises your chances for catching a cold or the flu, or make your skin itch. House-plants add moisture to the air. One study found a collection of spider plants boosted the relative humidty in a bedroom from 20% to a more comfortable 30%.

**Aloe for First Aid** – Gel from this plant is a popular home remedy. It can treat sunburns and other minor burns. It can soothe psoriasis and other skin conditions. Juice from the aloe plant can even help with constipation!
